U.S. CUSTOMS CLEARANCE AND TRADE COMPLIANCE REQUESTS: All PAPS ACE manifest, NOTIFY PARTY and import documents should be sent to <u>melling@arc-scs.com</u>.

When requesting Customs clearance please submit the following minimum documents:

- Commercial invoice & packing list.
- Arrival notice with any release charges and free days clearly noted.
- Any other government agency documents as required.
- Certificate of origin if applicable for free trade agreements.
- Copy or any master and house bill of ladings for air, ocean or ground entries.

BILLING ON POD SUBMISSION:

All invoices should be submitted to <u>arcadmin@arc-scs.com</u>. Documents should include at a minimum:

- Vendor invoice listing the ARC Load # on the invoice.
- Clearly signed and dated POD.
- Shipper BOL/Packing Slip.
- Payment remittance address.
